

2019 Authentic Stoneville® Cotton Program

Terms and Conditions

Criteria: To apply to the Stoneville Legacy Club™, you must meet the following criteria:

- i. Plant Stoneville Cotton Seed on a minimum of 20 acres from January 1, 2019 - December 31, 2019.
- ii. Grow cotton in one of the following states: AL, AR, FL, GA, LA, MO, MS, NC, SC, TN, VA and certain Texas counties*.
** Aransas, Atascosa, Austin, Baylor, Bee, Bell, Bexar, Bosque, Brazoria, Brazos, Burleson, Caldwell, Calhoun, Cameron, Clay, Collin, Colorado, Cooke, Coryell, Dallas, Delta, Ellis, Falls, Fannin, Fort Bend, Frio, Grayson, Grimes, Guadalupe, Hays, Hidalgo, Hill, Houston, Hunt, Jackson, Jim Wells, Johnson, Karnes, Kinney, Kleberg, Lamar, Limestone, Live Oak, Matagorda, McLennan, Medina, Milam, Navarro, Nueces, Red River, Refugio, Robertson, San Patricio, Starr, Travis, Uvalde, Victoria, Walker, Washington, Wharton, Willacy, Williamson, Wilson, Zapata, Zavala*
- iii. Provide and complete gin recap sheets and qualification forms (collectively "Forms") to verify yield (minimum of 20 acres planted with 100% Stoneville cotton seed) by January 15, 2020.
- iv. Register cotton in the Authentic Stoneville Cotton program.

Applicants who rank in the top 10 percent of yields submitted for their state qualify to receive an all-expenses-paid trip for two to The Henderson Beach Resort in Destin, Florida. Growers who produce cotton in multiple states will only be recognized in the state for which the highest yields were submitted.

Forms & Verification: Forms submitted via fax, email, or mail must be received by January 15, 2020 to qualify. BASF is not responsible for lost, late, illegible, misdirected, mutilated, incomplete, or postage-due-mail for submitted Forms. Submissions become property of BASF and will not be returned. Any applicants who attempt to apply with multiple addresses, under multiple identities, and/or attempt to use one set of qualifying criteria of a single farm to multiple applicants may be disqualified and forfeit any and all benefits, in BASF's sole discretion. Multiple applicants are not permitted to share the same qualifying criteria of a single farm, except as otherwise permitted in BASF's sole discretion. Should multiple applicants of the same farm apply, and a dispute thereafter arises regarding the identity of the authorized applicant, BASF may resolve such dispute in its sole discretion.

BASF will review and verify all Forms for accuracy. BASF reserves the right to audit acres/yield and production acreage certification reported in any applicant's Forms to verify eligibility, in BASF's sole discretion. Any applicant's Forms or subsequent documentation which is found not to be eligible will be disregarded and will not be eligible for any benefits. Ineligible individuals may not receive notification or any correspondence from BASF. Applicants who are determined to qualify will receive a notification. BASF is not responsible for any incorrect or change of email address, mailing address and/or telephone number of applicants. BASF is not responsible for any applicant's failure to receive his/her notification, regardless of the cause.

By participating, you agree (a) to be bound by all applicable terms and conditions; (b) as between you and the BASF, that the decisions of the BASF is final on all matters relating to the Authentic Stoneville® Cotton Program and Legacy Club (collectively "Legacy Club") and any benefits thereof; and (c) in the event that you do not comply with these rules, that you will be disqualified and your benefits (if any) will be forfeited.

Benefits: Qualified applicants may receive special Stoneville Legacy Club apparel and other giveaway items. Applicants who rank in the top 10 percent of yields submitted for their state qualify to receive an all-expenses-paid trip for two where the top 10 percent yield growers will be recognized and celebrated.

Legacy Club related benefits, including travel and accommodations, are subject to availability and change and are at BASF's discretion. Furthermore, you represent, warrant, and certify that any permanent bale identification numbers (P.B.I.'s) submitted to the Authentic Stoneville Cotton database by you or on your behalf are actually bales of cotton produced from registered Stoneville seed that was purchased from an authorized Stoneville dealer. BASF will rely on this certification when issuing any certificate of authenticity pertaining to your 2019 Stoneville cotton crop.

Release: As a condition of applying, applicants agree: (a) to release BASF, its affiliates, subsidiaries, retailers and agents, and each of its officers, directors, employees and agents, from any and all liability, loss or damage incurred with respect to the awarding, receipt, possession, and/or use or misuse of any benefits; (b) under no circumstances will any applicant be permitted to obtain awards for, and applicant hereby knowingly and expressly waives all rights to claim, punitive, incidental, consequential or any other damages; (c) all causes of action arising out of or connected with this Legacy Club and any benefits thereof, shall be resolved individually, without resort to any form of class action; and (d) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred (if any), excluding attorneys' fees and court costs.

Binding Arbitration: Applicant agrees that: (i) any and all disputes, claims and causes of action arising out of or connected with the Legacy Club, or any benefits provided, other than those concerning the administration of the Legacy Club, shall be resolved individually, without resort to any form of class action; (ii) any and all disputes, claims and causes of action arising out of or connected with the Legacy Club, or any prizes awarded, shall be resolved exclusively by the US District Court for the Eastern District of North Carolina, or the appropriate North Carolina state court sitting in Durham County, NC; (iii) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with applying to the Legacy Club, but in no event attorneys' fees; and (iv) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
